



A TREATY

FOR THE ENACTING WITHIN THE SYRIXIAN COMMONWEALTH OF MEASURES TO COMBAT TERRORIST ACTIVITY IN THE MODERN DAY

SIGNED IN PATALIPUTRA, SYRIXIAN EMPIRE; DATE TBD

THE COMMONWEALTH COUNCIL,

RECOGNIZING THE LOOMING THREAT OF MALICIOUS NON-STATE ACTORS SUCH AS TERRORISTS AND ASSOCIATED ORGANIZATIONS IN THE MODERN DAY,

ACKNOWLEDGING THE ATROCITIES COMMITTED IN RECENT YEARS BY TERRORIST ORGANIZATIONS OPERATING ILLEGALLY IN VARIOUS SOVEREIGN STATES ACROSS THE GLOBE,

CONCERNED FOR THE SAFETY OF OUR OWN STATES AMIDST THIS NEW THREAT CONSIDERING THAT WAR CAN NO LONGER BE CONFINED SOLELY TO THE BATTLEFIELD,

AND REMAINING COMMITTED TO THE CORE VALUES OF BROTHERHOOD AND SOLIDARITY THAT HAVE DEFINED AND GUIDED THE COMMONWEALTH SINCE ITS FOUNDATION,

HEREBY DECLARE THE FORMATION OF A COMMONWEALTH SECURITY COMMAND (CSC) AND TWO RAPID RESPONSE BRIGADES (CRRBs), UNDER THE AUSPICES OF THIS COUNCIL, AS WELL AS THE FORMATION OF A COMMONWEALTH DEFENSE AGREEMENT.

ARTICLE 1. REGARDING A COMMONWEALTH SECURITY COMMAND (CSC)

1. CSC SHALL SERVE TO ASSIST THE MILITARIES AND INTELLIGENCE AGENCIES OF COMMONWEALTH MEMBERS IN COORDINATING MILITARY AND INTELLIGENCE OPERATIONS RELATING TO STATE AND NON-STATE ACTORS. TO OPT IN, MEMBERS MUST INDICATE THEIR DOING SO, FOLLOWED BY A CONTRIBUTION OF 0.033% OF ANNUAL MILITARY SPENDING TO CSC.
 2. CSC SHALL BE ADMINISTERED BY A DIRECTOR, WHO IN TURN MUST BE A SENIOR MILITARY OR INTELLIGENCE OFFICER FROM ANY COMMONWEALTH MEMBER PARTY TO CSC. THE DIRECTOR SHALL BE NOMINATED BY SAID MEMBERS PARTY TO CSC AND DETERMINED BY A MAJORITY VOTE OF THE SAME, FOLLOWED BY FINAL APPROVAL FROM THE HEAD OF THE COMMONWEALTH.
 3. CSC SHALL HAVE PERMANENT JURISDICTION OVER COMMONWEALTH MEMBERS PARTY TO IT, AND MAY THEREFORE OPERATE WITHIN NON-OBSERVING MEMBER STATES SHOULD THEIR RESPECTIVE GOVERNMENTS AGREE TO THE OPERATIONS.

ARTICLE 2. REGARDING A COMMONWEALTH DEFENSE AGREEMENT (CDA)

1. ANY ATTACK AGAINST A COMMONWEALTH MEMBER STATE PARTY TO THIS AGREEMENT SHALL BE CONSIDERED AN ATTACK AGAINST ALL SIGNATORIES, WHO SHALL, IN THE EVENT OF SUCH AN ATTACK, TAKE MEASURES TO PROVIDE FOR THE DEFENSE OF THE MEMBER IN QUESTION AND OF THE COMMONWEALTH.
 2. TO OPT IN TO THE COLLECTIVE DEFENSE AGREEMENT, MEMBERS MUST INDICATE THEIR DOING SO. DUE TO THE NATURE OF THIS AGREEMENT, NO MILITARY SPENDING COMMITMENTS ARE REQUIRED.

ARTICLE 3. REGARDING COMMONWEALTH RAPID RESPONSE BRIGADES (CRRBs)

1. TWO COMMONWEALTH RAPID RESPONSE BRIGADES SHALL BE ESTABLISHED FOR THE PURPOSE OF ENSURING A PROMPT RESPONSE TO ANY SERIOUS SECURITY THREATS TO THE INTEGRITY OF THE COMMONWEALTH.
 2. ONE CRRB SHALL BE CHARGED WITH DEALING WITH THREATS POSED TO THE COMMONWEALTH BY STATE ACTORS, WHILE THE OTHER SHALL BE CHARGED WITH DEALING WITH THREATS POSED BY TERRORISTS AND OTHER NON-STATE ACTORS.
 3. TO OPT IN, MEMBERS MUST BE PARTY TO CSC AND MUST INDICATE THEIR WILLINGNESS TO CONTRIBUTE, FOLLOWED BY A CONTRIBUTION OF 0.033% OF ANNUAL MILITARY SPENDING, DIVIDED IN TWO FOR EACH CRRB.
 4. MEMBERS CONTRIBUTING TO THE CRRBs MAY CHOOSE TO CONTRIBUTE ANYWHERE FROM 1000 TO 5000 SOLDIERS TO EACH CRRB. THESE SOLDIERS MUST BE CAPABLE OF SPEAKING SUCHARI, OR, ALTERNATIVELY, MERCANTI. CRRB COMMANDERS SHALL BE APPOINTED BY THE DIRECTOR OF CSC.
